- 1 Receive an invitation.
Your clinic will print or email an invitation to you
- 2 Click <https://clarity.dexcom.eu/share> or enter it into your internet browser.
Confirm to share before the expiration date
- 3 Click **Log in**.
If you use G5 Mobile, you already have an account. Log in with your G5 Mobile or any Dexcom username and password.
- 4 Enter your username and password, then click **Log In**.
- 5 Enter the Temporary Authorisation Key from your invitation.
- 6 Enter your date of birth.
- 7 Click **Continue**.
- 8 Click **I consent to share my data with my clinic**.
- 9 Click **Yes, Share My Data**.


